FOR IMMEDIATE RELEASE --Seattle, WA -- February 18, 2009 --- Seattle –based Seattle Chocolate Co. Inc. announced today a voluntary recall of all lots of Choxie Brand -Dark Chocolate Nut Truffle Meltaways as a precautionary measure due to the recall expansion of Peanut Corporation of America's Plainview, Texas facility. This voluntary recall is in response to the recall by the Texas Department of State Health Services (DSHS) for all Peanut Corporation of America (PCA) product that had been shipped from their Plainview Plant due to unsanitary conditions.

The recalled Choxie Brand items contain chocolate assortments which include Peanut Brittle Truffle(s) that contain candied peanuts originally sourced from the Plainview Texas, Peanut Corporation of America (PCA) facility.
